Sub: Implementation of the E.S.I. Act, 1948 Registration of Employees of the Factories and Establishments under Section 1(5) of the Act as amended.

- I have to inform that under Section 1 (3) of the E.S.I. Act, 1948 the Central Government has vide notification No. S.O.1529 dated 15.7.58 made the provisions of the Act applicable to all factories/Establishments covered under the Act within the Area Bangalore.
- I have further to inform you that the appropriate Government has extended the provision of the Act to other establishment under Section 1 (5) of the Act with effect from 27.1.85 (vide notification No. S.O. 271.101.85 dated 5.1.85)
- Under Section 2-A of the Act such a factory/Establishment is required to register first under the Act and chapter IV thereof casts a responsibility on the principal employer thereof to insure its employees and to pay contributions in respect of these employees covered under the Act.
- On the basis of the particulars in respect of your factory/Establishment submitted by you the report of the inspection conducted by the Insurance Inspector/Assistant Manager who inspected your factory/Establishment on 13/4 & 6/9/96 your factory/Establishment falls within the purview of Section 1(5) of the Act with effect from 1.1.85. In case, however, subsequent facts reveal that your factory/Establishment was covered from a date prior to the date mentioned above you shall make yourself liable to comply with the provision of the Act from such earlier date.
- You are requested to take immediate steps for registration of your employees by submitting Declaration forms, preparation of contribution cards and payment of contribution maintenance of record etc. from the date of coverage of your factory/Establishment under the Act.
- For the sake of convenience your establishment has been allotted code No. 53-14205-56 which may kindly be used in all communications sent to this office and on all forms at the places indicated for the purpose. The Local office of the Corporation situated at No.8/1, I Floor, 'E' Block, I Main Road, I Stage, Rajajinagar, Bangalore-10 has been instructed to render necessary assistance to you in connection with registration of your employees. In case you find any difficulty or for any other purpose which may be necessary in connection with the Scheme, you are requested to contact the Manager of the above Local office who will render necessary help in the matter.

Provident Fund Registration Certificate

Office of the Regional Provident Fund Commissioner, Bangalore. The form contains details for Sri. Laxmi Enterprises, No. 1077, 7th A Cross, Bangalore-70. It includes fields for name, address, and contact information. The main body of the certificate contains several numbered clauses (1) through (5) detailing the terms of registration, including the application of the Employees' Provident Funds Act, 1952, and the Schemes framed thereunder. It also specifies the contribution rates for both employer and employee, and the frequency of payments.

This document provides detailed instructions for employers regarding the Provident Fund registration process. It includes a table with columns for form numbers and their respective purposes. Key instructions include:

- Before paying wages, deduct the employee's contribution from their wages.
- Administrative charges should be paid within 15 days of the close of every month to the Accounts of the Fund.
- The rate of administrative charges is 0.50% subject to a minimum of Rs. 5/- and a maximum of Rs. 12/- of pay, basic wages, dearness allowance including cash value of any food concession and retarding allowance, if any.
- It may be noted that if timely deductions are not made from the member's wages, the employer will have to pay back the dues himself.
- The Family Pension Scheme will be applicable from retrospective date i.e. 1st of the month of issue of this cover-gate notice.
- Besides making deposits in account Numbers 7, 8, and 10 as explained above, you are also required to deposit the contributions and Adm. charges in Account No. 21 and 22 under the Employees' Deposit Linked Insurance Scheme 1978.
- Deposit Linked Insurance Fund Account No. 21: In this amount will be deposited the contributions of 0.50% which will be the aggregate of the basic wages, dearness allowance including and retarding allowance if any, payable to the employees by an employer.
- Regional Insurance Fund Administrative A/c No. 22: To this account will be deposited the administrative charges at 0.50% which will be the aggregate of the basic wages, dearness allowance (including the cash value of food concession and retarding allowance, if any), payable to the employees by an employer.
- The Deposit in the above accounts, viz., 7, 8, 10, 21, 22 are to be made by cheques attached and duplicate copies of the cheques as received from the Bank should be forwarded to this office duly attached with Form No. 12A (provided as explained below).
- You are required to maintain/forward the following returns:
 - Form No. 9 under the E.P.F. Scheme 1952 and Form No. 2 (E.P.F.) under the E.P.F. Scheme, 1971: These are to be submitted to this office once in respect of those employees who are required or entitled to become members on the date the factory/establishment is covered under the scheme.
 - Form No. 3 under the E.P.F. Scheme 1952 and also under the Scheme, 1971: These are to be obtained in duplicate from every member for submission to this office.
 - Form-5A: This is to be submitted to this office in duplicate. Any subsequent change in particulars is also to be notified to this office through this form.
 - Form No. 3-A: This is to be maintained at the factory/establishment in respect of every employee who is a member in which the contribution paid to the P.F. is to be paid every month.
 - Form No. 4-A: This is the annual return of contribution and is to be submitted to this office within 30 days of the close of the year.

This document contains further instructions and return requirements for the Provident Fund registration. It includes:

- Form No. 12-A: This is the monthly return of contributions and is to be submitted to this office by 25th day following month. Duplicate copies of the cheques in respect of the deposits made in the State Bank of India should be attached with this.
- Form No. 5 & 10: These are the returns of employees who have become new members or have left the service in the month and are to be submitted to this Office by the 15th of the following month irrespective of whether the particulars are for any month.
- All the forms prescribed under the Employees' Provident Funds Scheme 1952, the Family Pension Fund Scheme, 1971 and the Deposit Linked Insurance Scheme, 1978, are available in the P.F. office and will be SUPPLIED FREE OF COST on receipt of your indent. THE EMPLOYER, at home or elsewhere.
- Regarding Family Pension Fund Contributions, it should be separated from the Employer's Provident Fund contribution and shown separately in the respective form and submitted separately in A/c No. 10 from the month of March 1972 onwards.
- As regards E.P.F. and E.D.L.I. dues for the period from 01.03.1968 to 31.03.1972, the amounts should be remitted along with Form No. 12-A (Form No. 12-A) to the office of the Regional Provident Fund Commissioner, Bangalore. This is without prejudice to levy of damages for the delayed remittance.
- In case, the employees shown in Form-5 were the members of the establishment's Private Provident Fund at the commencement of the Scheme, the accumulations in the Private Provident Fund should be remitted into the State Bank of India to the credit of the E.P.F. A/c No. 1 through prescribed cheques and the duplicate copy of the cheques sent to this office. All the amounts relating to the Private Provident Fund accumulated in the establishment should be transferred to the E.P.F. within four months by issuing the securities transferred to and retained in favour of the Central Board of Trustees, Employees' Provident Fund, and the Securities thus transferred should be sent to this office. A note containing the instructions in the matter of transfer to these accumulations is enclosed. Cash on hand in relation to the Accounts of the Private Provident Fund should be remitted within 30 days from the date of this communication, failing which damages at the prescribed rates will have to be paid by you on the delayed remittance made in cash after the due date.
- The receipt of this letter along with its enclosures may kindly be acknowledged.

- Instructions regarding intimation of the Employees' Provident Fund Scheme, Employees' Family Pension Scheme and Employees' Deposit Linked Insurance Scheme.
- Instructions regarding allotment of Account Nos.
- Instructions regarding transfer of previous Provident Fund Accumulations and transfer of securities.
- Ready Reckoner for calculation of Provident Fund contribution, Family Pension contributions and Deposit Linked Insurance Contributions.
- Form 5A in duplicate.
- Copy to: 1. The Enforcement Officer, State/Zone for working compliance. He/She is to obtain S-A in duplicate in respect of the establishment immediately.
- 2. Accounts Branch/Sub Regional Office. (It is understood that this factory/establishment has/had no previous Provident Fund accumulations to transfer the E.P.F. This may please be noted in the contributions Register maintained in the Group with suitable remarks).
